## Board / Committee Reports and Other Business

There will be a Thanksgiving Day Marathon at the OAsis (first meeting at 9 am, last meeting at 4 pm) plus the regular meetings at the usual times.

Susie submitted the Profit & Loss Budget vs Actual statement for Jan.-Sept. 2013, and the proposed 2014 Budget (copies attached to the printed minutes in the Minutes notebook at the OAsis). After questions, discussion, motion and vote, the 2014 Budget was approved without dissent. Susie will be submit something to ReachOut about the approved 2014 Budget. Election Committee: Gregor reported that no one has yet been nominated for the open Board positions, and answered some questions about the nominating deadlines and self-nominations (write-in candidates) on the day of the election itself (okay -- if the nominee is personally present or has provided a <u>signed letter</u> (not just an email) stating that he or she will serve if elected).
