OPEN FORUM

An IG rep asked, "Is there a *successful* way to get people to do service at the meeting level?" The ensuing discussion covered all the comments elicited at the July IG meeting (see "Discussion About Service") and the August IG meeting (see "Continuing Discussion About Service").

There was a discussion about the problem with Zoom "bombers." To control bombers, someone at the meeting must have the host key to be able, at the very least, to mute the bomber. It is important for meetings to have both a host and co-host. If you are the host for a meeting, and you won't be there, please arrange for a backup host (ditto: other service positions). It was also suggested that, if a meeting has been bombed, it's traumatizing – so maybe after the bomber is eliminated, take a few minutes for the group to process the negative experience.

The Wednesday 7 pm meeting on OA Footsteps needs people to give service at the meeting.

It was reiterated that individual meetings are autonomous, so whether to continue a meeting or shut down (maybe for lack of service givers?) is up to *that* meeting, not the Intergroup.

The meeting was adjourned with the Serenity Prayer at 3:00 pm.
