A Diversity Committee would look at various attributes, such as type of eating disorder, gender identity, race, young people (18-30 years of age or young-at-heart), etc., and would identify whether members of the diversity community feel welcomed and included in OA and how we can

address any challenges. The general feeling was to have 2 separate Chair positions, unless we can't fill both positions. The Board will re-visit the question at the May Board meeting.
