NEW BUSINESS

Delineating "Open" from "Closed" meetings. "All meetings are open meetings." This topic was discussed at length. All meetings that are *listed on website are open meetings*, open to anyone including "visitors." Visitors would include students investigating OA for their studies (e.g., for report writing), health professionals like doctors or nurses, etc. Further, for example, specific focus meetings like specific diversity topic (e.g., LGBTQ) could be attended by a LGBTQ or non-LGBTQ person. Or, a Women's meeting may be attended by a man. Step 3: The only requirement for OA membership is a desire to stop eating compulsively.

Keren S. will research further via WSO, etc., and bring back for adoption clarification on "open" and "closed" meetings. It was noted that whatever format a meeting that format is to be dictated at the beginning of that meeting. Some discussion included "closed" meeting to observe anonymity to other compulsive eaters. A current example of "closed" meeting is a one that is using the "Twelve Step Workshop and Study Guide, Overeaters Anonymous." The group was formed as a group with a given start and end date and shortly after established it is closed to additional members and is not a "registered" meeting so it does not appear on the OA website, it does not have a "meeting number"; however, 7th Tradition is observed and those monies collected go to the General Fund rather a specific meeting number. In the past and theoretically some "closed" step study meetings allowed for more in-depth work within a designated group and there could be a rotation study buddies/partners within that set group, set participation list. In the past when there was a hardcopy list of meetings, the meetings were indicated as "open" or "closed." It was suggested that the first step in this process is to identify goals for closed meetings, open meetings, topic, for example. Does that imply "closed" or "open"? Orange County OA delineates open/closed meetings

Regarding "visitors" to a meeting, it was suggested to use the "waiting room" option on ZOOM to establish who are "visitors." In addition to various Board members discussing this issue, Jerry J., Iola, Vicki A., Pam V., Susan H, Christina, and Alice C. gave considerable input.

Separately, it was requested that monthly meeting highlights get distributed in a timelier manner.
