# Delineating "Open" from "Closed" meetings.

After lengthy discussion and research today and previous Board meetings via WSO, etc., the Board unanimously adopted the following regarding policy regarding Open vs. Closed Meetings:

1. The Board recommends that all San Diego County OA meetings be Open. Reason: We never know when we might help a newcomer or how the word is going to get out. Our first purpose is to get the word out to the compulsive eater who still suffers.

- 2. All meetings can decide for themselves if they wish to be Open or Closed (reiterated). Reason: If a registered meeting is Closed, even though the Board does not recommend that, it will still have access to the now four ZOOM meeting slots and will be listed on the OA website. Board acknowledges each meeting is autonomous, so if a meeting wishes to be Closed, that is their right.
- 3. OA San Diego Intergroup will list all Open and Closed meetings. The website will have the definition of what is an Open and what is a Closed meeting where it says "Upcoming Meetings." Closed meetings will say in parenthesis, "(Closed)".
